Walter Ashby Plecker, along with countless others was grossly instrumental with reclassifying aborigine indigenous peoples as: Negro, Mulatto, African-American, Colored, Black, etc... As a result, we know these terms on birth, death, marriage records, and other forms and documents always symbolizes code under "color of law" for reclassified aborigine Americans aka American Indians.

Whereas it is your duty and obligation to we the American Aborigines to secure and respect our creator given rights, man and woman created in the image of our Creator/The Great Spirit.

We are writing to you on behalf of our American Aborigine brother, arrived on Earth and became Jarvis of the Davis family but known to us as Chief Black Bird-White Tip; our sister, arrived on Earth and became Lotrice of the Glover family but known to us as Empress Everlasting Waters. We view you Richard, Lynn Scott, as a man acting in the capacity of Governor for the State of Florida; we hold you liable for the actions of your agents/agencies and or affiliates. We view you Pamela Jo Bondi, as a woman acting in the capacity of Attorney General for the State of Florida; we hold you liable for the actions of your agents/agencies and or affiliates. It is brought to our attention that you and or your agents, agencies, subsidiaries, businesses, Corporation etc has encroached on the property and rights of our indigenous brother and sister; their property also known as children has been taken away from them without their consent. Let it be very clear, we are not UNITED STATED citizens, we are not wards of ANY STATES, we are not Black, African Americans, or Africans; we are the posterity of the ancient Americans who lived on this landmass called America since time immemorial. We American Aborigines are indigenous to this land and we have the right to self determination, self governance and the right to be free of any and all forms of discrimination and genocide. We are bringing the fact that your actions and or the actions of your agents/agencies are causing us harm; we require of you to make it stop posthaste; we do not wish to be molested anymore. STOP NOW, YOU ARE HURTING US indigenous peoples; this is fair and just warning; we will seek fair and just compensation, redress and or restitution for damages. You are HURTING OUR FAMILY and our wish is to make it stop now. We ask that the harassment be stopped, and the restoration of our property known as children NOW. In our culture it takes + a village/tribes to raise our children, therefore, this is the village/tribes reaching out to you to resolve this matter immediately. We require of you to respond to this letter within ten (10 days) of you receiving it to the address below; we thank you for your time and quick resolve.
